2. No structures are provided. You will receive a location assignment and access instructions approximately one week prior to the event.
3. Vendor is responsible for obtaining all correct permits to conduct business at the festival. For food vendors, contact the North Shore Health Department health sanitarian.
4. The BID will not provide or have access to electricity for vendors. Generators must be portable and rated at 80 decibels or less.
5. Your vehicle must be out of the event area by 10:30 a.m. Setup may begin at 8:00 a.m.
6. All booths must be open and staffed during hours of the event.
7. Vendor is responsible for removing own trash.
8. Signs are permitted only in your purchased booth area.
9. Distribution of promotional items must be approved by the Feast Committee.
10. Any prize giveaways or drawings must be registered and approved in advance by BID management.
11. The festival is a rain or shine event. No refunds.
